Hospital deal in works

The hospital district is in negotiations with prospective partners and together plan to meet with creditors next week.

Hospital district CEO Neal Gold said during last week's board meeting they hope to present a plan to the bankruptcy court on Oct. 20.

During an interview following the meeting, Gold said they are currently discussing a plan where the partnership would

"buy into the business to generate sufficient cash to make a settlement offer to CMS (Centers for Medicare and Medicaid Services.'

The taxing district would remain in existence, and the real estate would be sold to the investment group, Gold said.

Currently, there are no other offers on the table, he added.

"Initially the plan was to get a single buyer. I don't have somebody who wants to buy the whole thing," Gold said.

The hospital district is currently in bankruptcy proceedings and reimbursements owed to the government for overpayments the district received in Medicare and Medicaid are key issue.

"The whole point of the partnership is to generate cash. We don't have cash to make a settle-

Three men came before the city council to comment on the tax before the vote.

EMS decides tax rate

and a delay in tax bills, Adair County EMS has voted to set the compensating tax rate this year, EMS Director Tony Bragg said.

EMS did not receive notifications until late into the tax rate approval window and did not have time to go through the necessary steps to approve a 4 percent tax increase, which was the original intent of the board. As a

After a miscommunication result, EMS was forced to take the compensating rate.

The tax rate last year was .040 percent, and this year it will be .041 percent.

At a special called meeting held on Sept. 26, the EMS board voted to accept the compensating rate due to the lack of other options, Bragg said. The rate will
